#### Preamble for the 7x Contributor Licensing Agreement

### 1. IMPORTANT NOTICES

### 2. Parties

This Agreement is between 7x, a limited liability company incorporated under the laws of Norway ("7x") and the copyright owner (or legal entity authorized by the copyright owner) identified below.

### 3. Definitions

- **"Contributor" ("You" or "Your")** shall mean the copyright owner (or legal entity authorized by the copyright owner) making this Agreement with 7x. For legal entities, the entity making a Contribution and all other entities that control, are controlled by, or are

under common control with that entity are considered to be a single Contributor. For the purposes of this definition, "control" means (a) the power, direct or indirect, to cause the direction or management of such entity, whether by contract or otherwise, or (b) ownership of fifty percent (50%) or more of the outstanding shares, or (c) beneficial ownership of such entity.

- **"Contribution"** shall mean any original work of authorship, including any modifications or additions to an existing work, that is intentionally submitted by You to 7x for inclusion in, or documentation of, any of the products owned or managed by 7x (the "Work"). For the purposes of this definition, "submitted" means any form of electronic, verbal, or written communication sent to 7x or its representatives that is explicitly meant to share the Contribution with 7x, including but not limited to communication on electronic mailing lists, source code control systems, and issue tracking systems that are managed by, or on behalf of, 7x for the purpose of discussing and improving the Work, but excluding communication that is conspicuously marked or otherwise designated in writing by You as "Not a Contribution."

### 4. Grant of Copyright License

Subject to the terms and conditions of this Agreement, You hereby grant to 7x and to recipients of software distributed by 7x a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable copyright license to reproduce, prepare derivative works of, publicly display, publicly perform, sub-license, and distribute Your Contributions, including derivative works of Your Contributions.

### 5. Grant of Patent License

Subject to the terms and conditions of this Agreement, You hereby grant to 7x and to recipients of software distributed by 7x a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable (except as stated in this section) patent license to make, have made, use, offer to sell, sell, import, and otherwise transfer the Work, where such license applies only to those patent claims licensable by You that are necessarily infringed by Your Contribution(s) alone or by combination of Your Contribution(s) with the Work to which such Contribution(s) was submitted. If any entity institutes patent litigation against You or any other entity (including a cross-claim or counterclaim in a lawsuit) alleging that your Contribution, or the Work to which you have contributed, constitutes direct or contributory patent infringement, then any patent licenses granted to that entity under this Agreement for that Contribution or Work shall terminate as of the date such litigation is filed.

### 6. Legal Representation

You represent that you are legally entitled to grant the above license. If Your employer(s) has rights to intellectual property that you create that includes your Contributions, you represent that you have received permission to make Contributions on behalf of that employer, that your employer has waived such rights for your Contributions to 7x, or that your employer has executed a separate Agreement with 7x.

### 7. Original Work Representation

You represent that each of Your Contributions is Your original creation. You represent that Your Contribution submissions include complete details of any third-party license or other restriction (including, but not limited to, related patents and trademarks) of which you are personally aware and which are associated with any part of Your Contributions.

### 8. No Support

You are not expected to provide support for Your Contributions, except to the extent You desire to provide support. You may provide support for free, for a fee, or not at all.

### 9. No Warranty

Unless required by applicable law or agreed to in writing, You provide Your Contributions on an "AS IS" BASIS, WITHOUT WARRANTIES OR CONDITIONS OF ANY KIND, either express or implied, including, without limitation, any warranties or conditions of TITLE, NON-INFRINGEMENT, MERCHANTABILITY, or FITNESS FOR A PARTICULAR PURPOSE.

### 10. Notification of Inaccuracies

You agree to notify 7x of any facts or circumstances of which you become aware that would make these representations inaccurate in any respect.
